Message from our President

No one could have foretold what 2020 would be like. The impact of Covid-19 turned our personal lives and the societies that we live in upside down. Our members faced an unimaginable crisis. Many services were required to close by authorities as they sought to cut transmission of the virus. The managers of those services that continued to function suddenly had to become experts in protective clothing and finding scarce supplies Members were confronted with invidious choices about what to do with their staff – whether it was to cut salaries, cut the numbers employed or do both.

The situation for people with disabilities was grim. Often endangered by medical conditions that left them vulnerable to the virus, there were major concerns about whether hard pressed health services would neglect them. Even more tragically, those individuals still living in institutions were at risk of the deadly virus sweeping through all residents and staff. All too often, parents and relatives of the individuals that our members had supported prior to the pandemic were left isolated and alone.

Yet remarkably, so many of our member organisations found ways to change their service, to find new ways to help people, to embrace digital communications and technology and frequently to do it with little cash. I feel truly humble thinking of what our members achieved during 2020. At EASPD we had to completely rethink how we operated. General Assembly and other governance meetings all had to move on line as did all seminars, member fora and conferences in Paris and Cork. New ways had to be found to share good practice and to pursue our policy goals.

You will learn more about what we did in this report, but I am truly proud of the pioneering work our Secretariat did during 2020. They were key to us successfully implementing our new statutes, governance rules and the election of a new Board at our virtual Cork conference through digital voting. Our French and Irish partners for the conferences were of tremendous assistance. The webinars took place frequently, sometimes weekly, on a huge range of topics. They had presentations from top quality experts, all designed to assist our members and supporters to respond to the crisis. Your participation, in large numbers, for every webinar demonstrated how much you valued them.

Much of what we report on in this Annual Report was borne through adversity. I nonetheless believe you will find much here to make you turn the pages. For me, this report amply demonstrates the solidarity that crosses national boundaries and lives strongly within EASPD.







REPRESENTATION

In one of the most challenging years to hit our sector and the world, EASPD has used all its efforts to present and draw urgent attention to the reality of support service providers during the pandemic. Our work this year has centred around ensuring the full recognition of the role of the sector and vital role in society in Europe, during COVID-19 and always. Crucially EASPD has worked to connect European and international policies with national and local priorities to make sure our sector is not left behind during the EU's recovery from the crisis.

PARTNERSHIPS

European expert group on transition from Institutional to community-based care

EASPD was an active member of the European Expert Group on transition from institutional to community-based care (EEG) in 2020. EASPD participated in the 10 years anniversary of the EEG celebrated during an international <u>event</u> organised on the 16th January. Moreover, EASPD took part in the EEG open meetings debating with the European Commission particularly on the resilience and threats faced by support services during the COVID-19 pandemic.

European Commission High Level Group on Disability

EASPD contributed to the group and its meetings and raised important issues such as:

- the **relevance** of the role of support services to support the implementation of the UN CRPD and the next European Disability Strategy,
- the need to **better invest** into support services, particularly acknowledging the difficulties faced during the pandemic which put the viability of the support services sector at threat,
- highlighting the need to ensure workforce of disability services are properly trained and benefiting from adequate working conditions which are a prerequisite to **ensure recruitment and retention**.

European Day of Persons with Disabilities

At the European Day of Persons with Disabilities, EASPD re-affirmed the importance of the EU Budget in funding innovative projects in the field of services for persons with disabilities and how it has been a key facilitator of the UN CRPD across the European Union. Highlighting the importance of the European Social Fund +, the European Regional Development Fund and REACT-EU, as well as the new Recovery and Resilience Facility, Thomas Bignal added that Managing Authorities should use these instruments to support progress (as they don't have to) and recommended the disability movement to lobby for this to happen.

EU Alliance for Investing in Children

EASPD together with our partners in the EU Alliance for Investing in Children, adovocated for the protection of children and their families during and after the COVID-19 crisis. Together, we contributed to the European Commission Public Consultation on the Child Guarantee expected to be released in early 2021, and called for more European committment to tackling child poverty and that it be prioritised in the EU Recovery Package and the 2021-2027 EU Multi Financial Framework.

European Commission Working Group on Early Childhood Education and Care (ECEC)

Following its work started in 2019, EASPD participated in the quality of expert on inclusion in the European Commission's working group on ECEC. This group is formed of representatives from each EU&EEA national governments together with 8 expert organisation, with the aim of facilitating the exchange of ideas and promising practices, and support national reform processes. 2020 saw the end of this group's mandate, and the publication of reports to inform policy makers. "ECEC - How to recruit, train and motivate well-qualified staff" focused on the professionalisation and attractiveness of ECEC services, while the "Toolkit for inclusive early childhood education and care" provides promising pathways to make ECEC services more inclusive. EASPD has been delighted to support the development of these documents, which offer useful tools to make European early education services more inclusive and in line with the UNCRPD.



POLICY MILESTONES

1

COVID-19

COVID-19 was the focus of our attention in 2020. In particular, ensuring that the EU's policy response supports the sector's management of the crisis and its recovery. We brought together the 12 major European networks of social services through the Coordinated Action on Social Services and COVID-19 and launched the campaign #SocialServicesAreEssentialServices to serve as a platform for support service providers to showcase the vital work they provide, and underline their needs in responding to COVID-19.

The Coordinated Action hosted numerous formal and informal exchanges with the EU institutions and even at the highest level with several meetings with Vice President of the European Commission Dubravka Suica and the Vice President of the European Parliament. This boosted the recognition of the issues impacting social services in several key European Commission and Parliament initiatives: from additional <u>EU funds</u>, to its medium term economic strategy (<u>European Semester</u>, etc) to its policies in areas such as <u>Public Procurement</u> or State Aid.

We worked to ensure that part of the Coronavirus Response Investment Initiative (CRII) is dedicated to covering the additional costs and lowered income of support service providers across the continent. The European Commission responded with a Helpdesk Webinar, attended by 600 participants. Following the Helpdesk on Access to EU funds for Social Services and the Social Summit on Social Services & COVID19, the Coordinated Action is now regularly meeting relevant EU officials and policy makers through its dedicated "Taskforce on Social Services & COVID19". We expect this to lead to long-lasting developments in the social field at European level.

The Coordinated Action joined together organisations representing support service providers who work with older persons, persons with disabilities, homeless persons, persons in or at risk of poverty, those with abusive partners or family members, vulnerable children and young people, refugees and asylum seekers, as well as people with addiction as part of a European wide social action! We reached out to our members and collected information from grassroots level as part of our campaign #SocialServicesAreEssentialServices. The highlight was on 25th June, when we held an online summit 'Social Services and COVID-19: what role for EU?' to show EU governance how essential services are.

EU Social Policy Agenda

The European Commission has planned an ambitious social policy agenda for 2021; which meant that 2020 was a key year in terms of preparations for the different files.

The next European Disability Strategy (EDS) was very high up on our agenda. EASPD was at the forefront of both formal and informal discussions with the European Commission and the European Parliament, including with Commissioner Nicholas Schmit in charge of jobs and social rights. To facilitate these discussions, EASPD prepared and launched a position paper on the next EDS, as well as a response to the public consultation by the European Commission.

The EU Commission has also promised to do an Action Plan for the European Pillar of Social Rights, the EU's compass for the development of our social welfare systems. Together with members, EASPD developed a <u>Position Paper</u> on what we would like to see in this Action Plan focusing on five key principles of the Pillar.

Children were also high up on the Commission's agenda as they are preparing to launch a proposal for a EU Child Guarantee and Strategy in early 2021. Having already highlighted that children with disabilities and access to support services will be important parts of the Child Guarantee, EASPD was very active in trying to shape the upcoming proposal both with a position of our own, as well as through different partnerships (EU Alliance for Investing in Children), working groups (Working Group on ECEC) and policy fields (European Semester). The Commission also launched the European Education Area, which following pressure from EASPD, included a clear statement in favour of inclusive education and the UN CRPD.


In December 2020, EASPD presented all these reports with the co-legislators through a dedicated meeting with Members of the European Parliament: Disabilities Services are Social Rights Enablers. Now, of course, we will have to wait until the initiatives are launched in 2021. In the meanwhile, backed with these positions and the experts of our members, EASPD will continue to be active in promoting the key role of Disability Services in implementing these policies.

Social Services Eco-system (funding and workforce)

This year, the EU had to negotiate its long term budget and Recovery Plan in response to the pandemic. Throughout 2020, EASPD has been active in the decision-making process for these funds, for example helping to open up REACT-EU for social services and employment of disadvantaged groups. We informed our members about these programmes, showing them how to engage with their national authorities to further shape the use of many of these funds.

We were also active on EU legal frameworks and pushed for the appropriate use of Public Procurement for the EU recovery and for strengthening the case for state aid rules to be kept and applied throughout Europe. We organised a key event to explore alternatives to public procurement in the funding of social care services, presenting our report on the topic.

EVENTS

Seminars became webinars in 2020. Although we missed being in the same room as our colleagues and struggled with the 'mute' button at first, we quckly adapted to the situation and took advantage of what technology had to offer. With our online events we were still able to bring people together for imporant discussions, and reached more people than ever before.

7th April

#FundInclusion Webinar

At this online event, we launched and presented our study 'Alternatives to Public Procurement in Social Care and Support'. The discussion between participants and speakers revolved around the extent to which public procurement, reserved markets and professional budgets can help social care and support providers to be more in line with the principles of the UN Convention on the Right of Persons with Disabilities.







4th-5th May

EASPD Annual Conference 'Road to Employment for Persons with Disabilities'

Intended to be held in Paris and hosted with LADAPT, he two-day event brought together support service providers, persons with disabilities, the European Commission, the International Labour Organisation, businesses as well as other stakeholders, and analysed the barriers that are still preventing the complete inclusion of persons with disabilities in the open labour market. Speakers shared good practices and It was also an opportunity to identify the key recommendations which must be considered for the next European Disability Strategy and effective implementation of Article 27 of the UN CRPD. The winners of the 4th edition of the EASPD Employment awards were announced, an award presented to social care and support providers, businesses or employers who have designed and implemented effective and innovative systems for the employment of people with disabilities. 6 of the promising practices submitted were chosen to be published in our Employment For All booklet.

Social Summit: Social Services and Covid-19: What role for the EU?

On 25 June 2020, EASPD and the entire social services sector came together at European level to call the European Union to strengthen recognition, urgency and resilience in social services during the COVID-19 pandemic and the recovery. The <u>Online Summit</u> was an opportunity for the sector to engage with high level European policy and thought leaders: the Vice President of the European Parliament Dimitrios Papadimoulis, the Vice President of the European Commission Dubravka Šuica, Member of European Parliament Dragoş Pîslaru and University Professor Frank Vandenbroucke. A joint position paper representing the entire social services sector was presented.

Early Childhood Intervention in Europe: How can the EU support children with disabilities from the very first step?

EASPD, in collaboration with the ECI Agora project, collected data on the state of play of Early Childhood Intervention in Bulgaria, Croatia, Finland, Greece, Poland, Slovakia, and Albania, and included recommendations for EU policy makers in the report "Early Childhood Intervention in Europe – How can the EU support children with disabilities from the very first step?". The webinar welcomed speakers from each of these countries representing both civil society and Commission desk officers responsible for developingnational reports. The event was an opportunity to discuss the challenges faced by service providers across Europe and how to address them.

14th-15th December

EASPD Annual Conference 'Art of Inclusion: Disability and Diversity in Arts and Culture'

EASPD, Cope Foundation and the European Network of Cultural Centres joined forces in this event that was supposed to take place in Cork, Ireland. Even if it was moved online, we still managed to recreate the <u>spirit of Ireland through music and art</u>. The conference addressed how we can promote the inclusion of persons with disabilities in mainstream arts and culture. It showcased the work of artists and performers from across the world while calling for a clear strategy to prioritise and facilitate the engagement of disabled artists and professionals in the cultural sector as a whole, as well as promote the visibility of these artists and their work. With the participation of representatives of the European institutions and United Nations, professional artists and experts, the event illustrated the urgent need for the full implementation of Article 30 of the UN CRPD, the right of persons with disabilities to paricipate in cultural life. UN Conference of States Parties to the CRPD

This year COSP did not take place in New York as usual and was moved online, but EASPD was still there with our side event 'How can we use arts and culture to promote inclusion of persons with disabilities?' The event speakers presented models of inclusion of persons with disabilities in the arts and culture sector, aiming to discuss frameworks that can eliminate cultural exclusion of persons with disabilities. Moreover, recommendations on how to achieve the implementation of Article 30 were formulated to Member States and all relevant stakeholders.

One main message appeared throughout: COVID-19 has re-affirmed the need to strengthen a disability services system built on the principles of the UN Convention on the Rights of Persons with Disabilities.





INNOVATION AND KNOW-HOW

In 2020, EASPD strived to play a leading and convening role in the development of innovative support models for persons with disabilities. To do this we facilitated further innovation in the sector, identifying and contributing to the design, development and sharing of innovative support models.

Workforce Development



Advancing Personal and Household Services (Ad-PHS)

There are two main sectoral activities in Personal and Household Services (PHS): social care and household support, yet with a possible growing overlap between the two. Current societal developments such as changes to family structures and the general ageing of our society increases the need for PHS. The overarching objective of the Ad-PHS project is to lead to the creation of a platform of relevant PHS stakeholders at EU level, to create a single point-of contact to support, guide and provide advice to Public Authorities in the development of their PHS policies. In December 2020, the project held its <u>final event</u> following 2 years of work. The speakers discussed the importance and the challenges of PHS through simultaneous round tables and a panel discussion with very interesting proposals for the future of the sector.

Enhance (European Curriculum for Family and Community Nurses)

A4i (Alliance for Inclusive Investment in Social Care and Support)

Europe has an investment gap in social infrastructure of an estimated €150 billion a year for the next decade in health, social care and support, education and affordable housing. There is a crucial need of a new breed of decision makers who have the skills and confidence to secure financing from both public and private sources, the <u>a4i project</u> aims at bridging this gap. 2020 saw a great number of accomplishments for a4i, despite the challenging context of the coronavirus crisis. it launched the first version of the State-of-the-art report providing a clear European assessment on social investment in social care and support, and European Guidelines on Quality Social Investment, which aim to provide the basic guidelines on social investment from a cross-European perspective.

IE+: Promoting positive attitudes and evidence-based policy for inclusive education


This project aims to provide decision-makers (policy-makers and education providers) with the information, training and tools that allow for evidence based policy making. BEYOND aims to empower special schools and service providers supporting children with special needs, to facilitate the transition towards fully inclusive education systems. The project will provide them with targeted information and tools to enable them to promote the acquisition of skills and competencies and support mainstream schools with the transition towards inclusive settings. The project is currently preparing for their conference in May 2021 which will address the key challenges and opportunities for the inclusion of all learners in mainstream schools as well as promote promising practices in the field of education.

The previous project IMAS I showed that the working conditions of learning support assistants are characterised by high workloads, little job security, low status in school hierarchies and low qualifications. Based on these findings, the follow-up project IMAS II wants to ensure the further development and strengthening of inclusive competences of learning and support assistants. The aim of the project is to develop <u>5 web-based knowledge modules</u> for different topics (e.g. ASD, ADHD, etc.) to give both practical and theoretical knowledge on how to support and strengthen the learning of children with disabilities, and develop competencies for inclusive practice. In 2020, the project has been busy preparing the online modules available in English, German, Portuguese, Slovak and Bulgarian!


Disability service in non-EU countries: state-of-play of the service provision sector in Albania, Armenia, Moldova, North Macedonia and Turkey





EASPD Lighthouse Network




Despite the stormy seas of 2020, the second annual edition of the EASPD's Lighthouse Network was successfully completed with two new training activities implemented between EASPD members. The Lighthouse Network is a space of contact among peers with certain expertise and organisations that express needs on those topics. The Network is engaged from (and for) EASPD's membership. Selected peer-experts work with other organisations to improve their knowledge and/or to increase their capacities.

In 2020, two matches were made between EASPD member organisations, who were looking to building their capacity on a key topic and four Lighthouse Network experts, who were willing to share their knowledge with others. Despite COVID-19, these training activities were successfully adapted to be delivered in an on-line format, assuring a constant flow of learning and exchanges!

Our Finnish expert, Maarit Alto, gave a 4-day training to highly motivated staff members from AMIMONI, a Greek organisation. The online course aimed to explore a way to renew the working methods and develop the understanding of person-centred notions when it comes to supporting persons with disabilities.

For the second training, our Spanish experts, Pep Solé and Ferran Blanco from SUPPORT as well as Raùl Olivera from Som Fundació gave a training on Supported Decision Making to three EASPD members: Eudajmonia from Poland, Help the Life Association from Albania and Disability Federation Ireland. Professionals from the three receiving organisations were very interested in learning more about supported decision making (SDM) and how they could better implement it in their respective organisations.

EURECO

On the 5th and 6th of March, EASPD and partners hosted the annual European research platform for inclusive community planning and service development for people with disabilities (EURECO) joint Research Forum 2020. 'Supporting inclusive health for ALL' was the title and theme of the gathering. The participants had the chance to discuss the implementation of Article 25 of the UN Convention on the Rights of Persons with Disabilities in relation to health care provision to persons with disabilities, the research needs on such topic in the EU and policy recommendations to decision makers.



EURECO Research Forum 2020, 6th March



In November, the platform organised the online event, 'New Horizons in Mental Health Care: Strengthening mental health services by peer-expertise and digitalisation'. It was a space for participants to exchange ideas and engage with a panel of international speakers on the importance of peer expertise in mental health services design.

During the first wave of the Covid-19 pandemic, EASPD hosted <u>weekly webinars</u> to support its members and provide them with tools to face the unprecedented and unexpected situation. The webinars brought together experts and support services providers to discuss the key issues affecting the sector during the COVID-19 outbreak, and gave a platform to our members to highlight their challenging reality through the pandemic. Sessions ranged from the health needs of persons with disabilities in the pandemic to how we can mantain cultural connections during this difficult period. Each week we discussed issues that were topical. We heard from experts in Italy just as the pandemic was making its way to other areas in Europe and welcomed a Professor from the Wuhan University Institute for Human Rights Studies in China to hear how persons with disabilities had been affected on the other side of the world.

Joining Forces!

In March 2020, EASPD created a <u>Facebook group called 'Joining forces'</u>. It serves as a support space for members and service providers. Group members are encouraged to raise their concerns, ask for advice from their peers and share info on promising practices and the measures that they are implementing to ensure the safety of staff and users.

EASPD Member Fora (MF) represent the interest of EASPD in their own field through active research, policy development, advice and networking. The MFs are coordinated by two cochairs: one co-chair with a board member position elected by the General Assembly and an internally elected co-chair by the membership of each MF. In 2020, two new co-chairs were elected to each group. These are their achievements this year!

Workforce Development and Human Resources

aims to promote high standards of knowledge, skill, competence and understanding within the social care workforce of the EU in general and amongst those of EASPD members in particular as a means of delivering quality services.

The Members Forum has contributed to various activities carried out by EASPD this year. In terms of research, it has provided key inputs for the elaboration of a call for tender for a study on the short-term impact of COVID-19 on disability support services, considering the impact on organisations, services, and workforce in several EU countries. The MF has also provided key inputs for the development of User Requirements as part of the Smart4Health project which aims to develop a platform for health data. Finally, in terms of policy, it has contributed to various discussions and position papers, culminating in EASPD joining the EU Pact for Skills.

Policy Impact

measures and influences the impact of European policy and legislation on the disability sector.

The Policy Impact Group was very active in supporting EASPD's response to the COVID19 pandemic, in particular in the development of EASPD's two Snapshot reports on the impact of COVID19 on Disability Services (April and October), as well as the report on the regional COVID-19 investment needs, developed with the Coordinated Action group. This led to multiple high level meetings with Vice Presidents of the European Commission and European Parliament. Last but not least, the Policy Impact Group played a major role in the development of EASPD's positions on the next European Disability Strategy, the Action Plan for the European Pillar of Social Rights and the Child Guarantee.

In 2020 the MF on Education welcomed a number of new members and elected two new co-chairs. It supported EASPD's activities on COVID-19 with the webinar 'Ensuring access to education during COVID-19' and also contributed to EASPD's two snapshot reports on the impact of COVID-19 on Disability Services. Members of the Forum hosted a workshop on the transition from education to employment during EASPD's online conference 'The Road to Employment for Persons with Disabilities.' Throughout 2020, the MF worked with national experts in the field of education to develop Barometer reports on the state of inclusive education in 13 European Countries. These reports will be used to developed a longitudinal perspective of the development of inclusive education over the coming years.

Employment

focuses on employment-related policies and job-related service developments.

This year the MF on Employment came face to face with the challenges arising from the COVID-19 pandemic. Several emergency meetings were held and important input was provided by the Forum on the pandemic's impact on the employment of persons with disabilities. Members also exchanged experiences and best practices in tackling the consequences of the crisis. The MF contributed to the organisation of the EASPD Conference "Road to employment for Persons with Disabilities" and to the drafting of the "Employment Manifesto" following the event. In addition, a Hearing on Employment was organised in collaboration with other stakeholders where the outcome was a Joint Statement to EU policymakers, calling to ensure that every citizen has the right to decent work in an open and inclusive labour market. The forum provided its input to EASPD positions on the Action Plan for the European Pillar of Social Rights and the upcoming European Disability Agenda. The following studies were produced: "Opportunities and barriers of different employment models for persons with disabilities" by Prof. S. Beyer and "Employment for All: Six Best practices."

The Member Forum met twice over 2020 and has been actively debating issues related to support provision during the COVID-19 pandemic. All members have been very active in their communities to ensure continuation of support to the extent possible and have been seeking alternative ways to deliver support through online or remote systems. The challenges brought up by the pandemic highlighted the need for reinforcing advocacy actions at international and local level to better support individuals and their right to inclusive living. The coming months will therefore be dedicated to reinforce the dialogue with stakeholders and share experiences to build more resilient support systems.

Person-centred Technology

focuses on ICT and Assistive Technology and assesses the benefits that new technologies can bring to disabled people in areas such as communication, employment, commerce, learning, independence, safety and free time.

In 2020, the Person Centred Technology Member Forum concentrated mainly on development of the group in order to support EASPD's members in the process of moving online, a process forced by the pandemic. The Forum has grown from 4 to 48 members (25 full members and 23 observers) from 17 countries. This year members received 13 newsletters containing information about relevant events, publications, education and funding opportunities related to person-centred technology in the social sector such as assistive technologies, digital skills, e-health etc. The Forum organised two webinars during the first wave of the pandemic: "Service providers moving to on-line support during the COVID-19" pandemic (265 participants and over 1,400 viewers on Facebook) and "Face-to-face services moving to on-line mode" (64 participants and 325 viewers on Facebook).

Arts and Culture

provides a platform for the exchange of information, good practices and the promotion of inclusive practices in the field of supporting access to arts and culture.

2020 has been one of the most important years for EASPD's member forum on Arts and Culture since its creation. The group collected important data on the effects of the COVID-19 pandemic on artistic activities in disability services and on artists with disabilities and shared these results in a dedicated session as part of EASPD's Covid-19 webinar series. For the first time ever, EASPD hosted one of its annual conferences around the topic of cultural participation of persons with disabilities and called for better implementation of Article 30 of the UNCRPD. Despite COVID-19 restrictions and the online setting, members of the forum were still able to bring creativity to the Zoom platform and planned an inspiring, entertaining and thought provoking event that addressed key issues around inclusion and the artistic world. In December, members of the MF planned and spoke at EASPD's side event at the UN COSP 'How can we use arts and culture to promote inclusion of persons with disabilities?' organised with the European Commission.

Early Childhood Intervention (ECI)

promotes the building of an effective inclusive society by including persons with disabilities in every step of their lives and from the very early stages of life.

This year the Member Forum on ECI focused its work on supporting its members to face the COVID pandemic, and on participating in the debate on the Child Guarantee. A first webinar was organised where ECI services identified issues they were facing to support children in Europe, and exchanged ideas on solutions they had been able to implement, in particular in Bulgaria, Greece, and Spain. A second webinar was organised to look into how the European Semester, and European funding in general, can help support the development of children services, with examples from Albania, Croatia, Greece, Finland, Slovakia, Bulgaria, Poland. The Forum also co-organised a Policy Café on the Commission's consultation on a Council Recommendation on a Child Guarantee, to ensure the concerns and wishes of our sector were represented in this very important future legislation.

Provider Forum Bulgaria National Conference "Employment for All"

EASPD together with the National Alliance for Social Responsibility (NASO) and in partnership with public authorities, organised a national event on the employment. The key challenges and opportunities of persons with disabilities in the field of employment were discussed as well as the improvement of the quality of social services in Bulgaria. The event was also the first working meeting to take place after the recently passed law on social services and several professionals spoke on its creation and implementation.


Message from our Secretary General
